

Summary

This document provides a summary of the 2021 data Prologis provided to the federal Equal Employment Opportunity Commission.

- <u>People of Color</u>: Employees of color make up 32% of Prologis' US workforce, higher than the 29% industry benchmark. We are committed to continued improvement in this area.
- <u>Gender</u>: Women make up 50% of Prologis' US workforce. We have the opportunity to increase gender balance at the senior leadership level.

How did we get here?

Our formal Diversity, Equity and Inclusion (DEI) strategy aims to increase diverse representation throughout the organization. Since the strategy was launched in 2016:

- We have increased female representation of first and mid-level managers.
- We have increased people of color representation across the organization.

Action Plan

- To broaden candidate pools, we partner with industry leading organizations like ULI, NAIOP, NAREIT and REAP to ensure equal access to opportunities in our industry.
- In 2021, we formed five Employee Resource Groups (ERGs): Women, Asian-Americans, African-Americans, LGBTQIA+ and Latinx.
- In June 2021, we added a new Director of Talent & Inclusion to build our DEI roadmap and drive improvement in inclusive hiring and retention; DEI training and awareness; and leadership development initiatives.
- As part of our work to tackle unconscious bias, we continue to include benchmarked DEI
 questions as part of our annual engagement survey.
- In 2022, we launched the Prologis Diverse Leaders Program, which matches women and underrepresented minorities in mid-senior level leadership positions with senior leader mentors.
- In 2022, we're forming a Global DEI Committee consisting of internal Leaders and Executives, Employee Resource Group (ERG) leaders, and Culture Champions throughout Prologis.
- Prologis new Inclusive Leadership program is scheduled to rollout in Q3, 2022.
