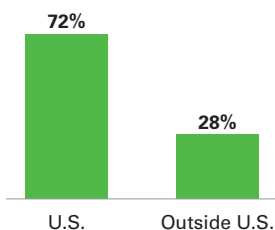

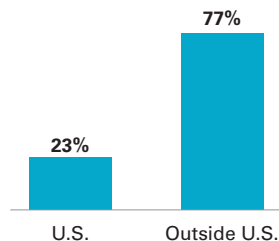

NOI by Business Segment

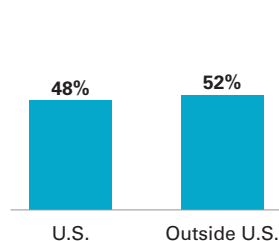

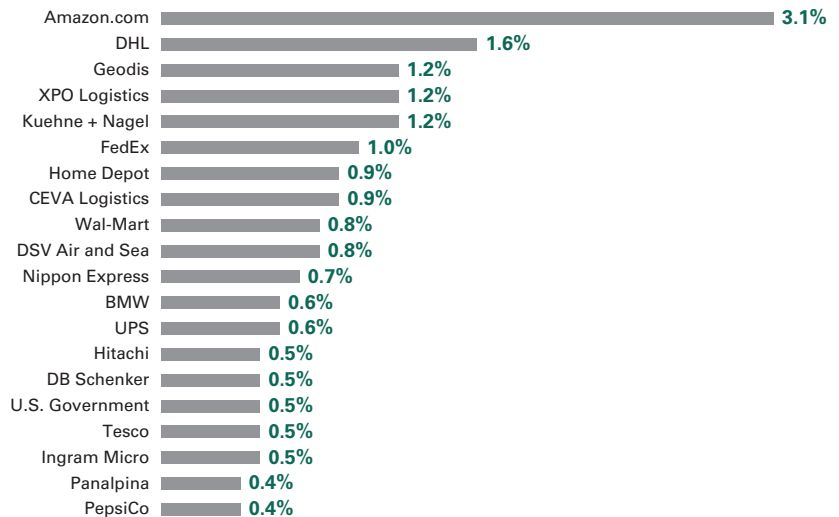
